It's March so it MUST be spring now and the temperatures SHOULD be improving. Let's hope so. And because it's spring, we know we're in Lent: the season for 'giving things up', but let me encourage you to think about it differently this year. Lent seems to prompt us to ask the question of others,



'What are you doing for Lent?', as if it's an individualistic thing. We should really not turn inwardly to ourselves, but begin with ourselves and see a transformed life in community and relationship, with God and with each other so that the question is rather, 'What are you **all** doing for Lent?'

For each of us who is serious about marking Lent well, the season begins with paying attention and beginning to make straight the way of the Lord by listening. This began on Ash Wednesday with our listening to the words of self-examination: 'We have not loved you...we have not loved our neighbours as ourselves...we have been deaf to your call....we confess our unfaithfulness, pride, hypocrisy and impatience...our self-indulgence and anger....our negligence in prayer and worship...' Lent is truly a time where we squirm at what we know are our failings and make reparation. If giving up chocolate, alcohol, or whatever helps you to do this, well and good, but you'll be doing this only for yourself. Collectively, perhaps we can give up, or take on, something else. The easiest thing in the world that we can do is to complain and moan and although there is plenty of opportunity for that in our current world and local situation, let's be counter-cultural! One year I was challenged by the Archbishop's Lent Book (when I was still in the Church of England) to give up complaining. Oh dear, oh dear. I'm afraid that lasted for about half a day. It focussed me though, and showed me how much the people around me were moaning and how much I moaned myself. It was the hardest Lenten challenge I've ever had. Think about it for yourselves. Maybe instead we could take on 'an attitude of gratitude' and make a daily list of things that we can give thanks for. Once we make a start, (family, friends, faith, food, homes, security, birdsong, daffs....) things will snowball, I promise. I also promise that if we rise to the challenge we'll be much happier by Easter.

Lent Course

To help you adopt 'an attitude of gratitude', this year's Lent Course might be a gentle place to start. It's based on the film, 'Chocolat' (not the book!) and the course runs on Monday evenings at the Rectory. starting promptly at 7.30. I have a limited number of chairs, so please let me know if you'd like to join in.

Giving something up for Lent

The Lenten 40-day period before Easter gives us the opportunity to reflect on the practice of fasting and commit to giving up something that brings a real benefit to nature and helps address climate change. Below are some changes you could make that will help the environment. Take time to pray, reflect and consider these options – pick one or two or however many you'd like (you never know the changes might just stick!)

Go plastic free. Even if you can't become totally plasticfree, make it your goal to at least reduce your use of plastic. Read Tom's month without plastic blog <u>here</u>.

Buy local or in bulk. Hannah shares how learning more about our food system has impacted what her and her family choose to consume. Read her blog <u>here.</u>

Switch off from digital. Explore technology-free times or areas of the house, switching to 'airplane mode' for the first hour in the morning and the last hour at night, 'switch off Sundays', reaching for your Bible over your device(s) and writing a list of outdoor things that you enjoy.

Try a plant-based recipe or diet. Start by cooking yourself vegan or plant-based meals once a week and take it from there. As time goes on, cook more vegan/vegetarian meals and try to eliminate as many animal products from your diet as you can. Explore tasty recipes with <u>Meat Free Monday</u> or read about Kayleigh's veganuary experience <u>here.</u>

Spend more time in nature. With weekly themes, <u>these</u> <u>'Get Outside in Lent' outdoor resources</u> profiled in our Eco Church resources will help you connect with God as Creator and celebrate his creation in different ways over the Lenten period.

Change your method of transport. How about <u>walking or</u> <u>cycling for repeated errands</u>, choosing one day a week to walk, cycle or take public transport to work where you are able to. Read about how Paul and his wife, Tara are changing the way they travel (and more!) <u>here</u>. **Boycott fast fashion.** Emily reflects on how our clothes can bring us closer to our neighbour and have a lesser impact on nature. Read her blog <u>here.</u>

Buy less or second hand. Read <u>here</u> how mum of 2, Nic started with small changes: using Facebook marketplace and ebay more to invest in second hand clothing and toys.

Become zero waste. Slowly try to reduce your waste a bit every week. Consider giving a home-made gift instead of buying a present, upcycling items or looking at your food shop and seeing what items you could buy differently, spending a bit more on loose fruit and veg for example.

Invite wildlife into your garden or church green space (with permission!). Read John's tips on greening our gardens for nature's benefit <u>here.</u> Where possible, invite and encourage others in your church community to be part of the journey, for example, planting seeds as part of the children's ministry or getting your church youth group to help build and stock up a hedgehog home.

Grow your own. Whether you have a garden or sunny windowsill, find out what you can sow and grow on a month-to-month basis <u>here</u>. Read how Vishadhi is using her home-grown food to bless her local community and food bank <u>here</u>.

Take a step to save energy in your home. From draughtproofing windows and doors to swapping your bath for a shower, <u>here's</u> a list of quick tips. You might be surprised at how many of these changes you've already made!

Move your money. Could you divest from fossil fuels and support a bank which invests in renewables? 'Good with Money' recommends some ethical choices <u>here</u> or for pension investments that help achieve the 17 Sustainable Development Goals set by the UN in 2015 there's '<u>Make my Money Matter</u>'.


A Rocha UK's Director of Conservation.

At the end of 2022 over 190 nations, including the UK, signed the Kunming-Montreal Protocol, committing governments to directly address the growing crisis facing biodiversity. The gathering was widely hailed as a landmark moment for nature.

At the heart of the agreement were four overarching goals focussing on landscape resilience and connectivity, enhancing biodiversity, equitable sharing of resources, and equitable access to financial support to restore natural systems. Specifically, the agreement has committed the signatories to ending the extinction of species, with a target of a ten-fold decrease in the rate of extinction by 2050. The protocol includes 23 targets which, if implemented, should achieve the overarching goals. The targets are admirably bold. Target two, for example, commits governments to protecting and actively restoring 30% of land and marine areas by 2030.

As the UK is one of the most nature-poor countries in Europe, the Protocol should be good news for our four nations. The reality is more complex. The UK government has indicated that by including all National Parks and Areas of Outstanding National Beauty, we are already so close to protecting 30% of our land and sea that the UK needs to take very little additional action.

Yet many of the UK's designated areas, such as Sites of Special Scientific Interest (SSSIs), are in such



Worse still, the UK government seems intent on reducing our environmental protections, just when the Kunming-Montreal Protocol suggests we should be tightening them. If the Retained EU Law (REUL) Bill continues its current path through parliament, then there is a real risk of important EU-derived environmental legislation being deleted entirely from the UK statute books, without replacement, by the end of 2023.

The picture is no prettier in the UK in relation to several other Protocol targets. Target seven, for example, commits governments to reducing the impacts of water pollution by 50% by 2030. But in the UK, unabated pollution of rivers and streams from sewage outfalls continues, and monitoring bodies such as the Environment Agency are chronically underfunded.

If global society achieves the goals of the new protocol, it will be a beautiful and life-giving gift to future generations. However, this will require most governments, including our own, to think and act very differently in relation to nature – and fast. This kind of mindset change is likely to require the voting public to push for it loudly and persistently.

Connect with God's creation over Lent (ideas from A Rocha)

As we begin the season of Lent this week, Lord, open our eyes each day to see something new and wonderful in your world, so we may choose to be more considerate towards your creation during this time of reflection and beyond.

Week One - Bring nature into your home or garden. What could you grow inside your home, in the garden or even at church? Plant a herb or flower as a reminder of our responsibility to steward God's earth. As you tend to this plant, prayerfully ask God how you might nurture nature better at home over the Lent period and beyond.

Week Two - Connect with creation in a new way. Time spent enjoying God's creation will help set your mind and seek the things that are above. Bring your sketch or note book, your Bible, or whatever helps you connect with our heavenly Father. Or perhaps God is inviting you to just bring yourself (with some extra layers!). Note all the signs of the season. Use this time to reflect on the changing season and what we can be thankful for.

Week Three - Discover the great outdoors with company. Meet up with a friend or several for an extended or brisk wintery walk together. You could visit an outstanding area of beauty in the UK or keep it local and soak up the seasonal sights on your doorstep in your nearest green space. Bring along a notepad and pens to write about or draw something that inspires you in nature and share your ideas and reflections.

Week Four - Plan a Wild Time! Plan something completely wild in nature for later this year. Experience kayaking, wild camping, forest school, forest church... Make sure to take the opportunity to **really** enjoy what nature has to offer beyond Lent. Break out of your normal routine and join a volunteer work party or take to the water for wild swimming. Whatever you do – do something different and have fun!

Week Five - Join us to protect and restore nature together. How can we make small changes in our everyday lives that can make a big difference to others and for your world? Contribute to positive change as part of an A Rocha UK community, as a church (Eco Church) and as an individual or family (Wild Christian).

Week Six - Be still in nature. During Holy Week, find a quiet spot outdoors and reflect on what Holy Week means to you. Surrounded by the beauty and creativity of nature, the shortcomings of humanity and our need for repentance are often clearer, but so also is the power and timelessness of God. Bring before him your own concerns and the needs of the natural world. Continue to pray with us via our weekly prayer diary at: arocha.org.uk/get-involved/pray

Easter Sunday - The Easter hope of reconciliation is good news for all. May we celebrate anew Christ's commitment in relating to his creation; that the Godman Jesus would enter into the deepest pains and realities of the flesh in order to restore the relationship between Creator and creature. By this restorative work all creation is reconciled to its intended delight, finding peace and mutual flourishing.

A date for our Annual Vestry Meeting was agreed Sunday 30th April at 10:00am in Nolton. More details will follow in due course. EARLY WARNING, please remember that this is the meeting at which we confirm or reappoint the various positions on the Ministry Area Council. Should ballots be required to fill positions you can only cast your vote if you are entered on the electoral register. The register, as compiled last year, still stands but you can add your name to it this year by filing in a registration form and passing it back to your church rep. The registration forms will appear in each church soon. There will also be nomination papers for the various positions available as necessary.

Council Tax Reduction Scheme agreed for 2023-2024

Bridgend County Borough Council has agreed to adopt a Council Tax Reduction Scheme for 2023-2024, which includes a discretionary element to ensure eligible residents can receive as much support as possible.



Council tax reduction provides assistance to those on low incomes, who are liable to pay council tax. Residents who are struggling to pay bills such as this, are encouraged to contact the council for an assessment to see if they qualify for any support.

The Council Tax Reduction Scheme has been developed by Welsh Government and local authorities are required to include several mandatory elements and to adopt any discretionary aspects by 31 January 2023.

Welsh Government have not made many significant changes to the required elements and depending on individual circumstances, eligible residents can still claim 100% council tax reduction. The new scheme will begin on 1 April 2023.

The changes set by Welsh Government include:

- Protection for hosts who are part of the Homes for Ukraine Scheme.
- Ukrainian nationals are now eligible for council tax reduction if they meet the criteria.
- European Economic Area (EEA) citizens, who are now subject to immigration control, are no longer eligible to be included in the scheme.

The council has also agreed to include a discretionary element to its Council Tax Reduction Scheme, which will see War Disablement Pensions and War Widows Pensions disregarded when calculating council tax reduction entitlement. This is expected to cost the council around £700,000.

Councillor Hywel Williams, Cabinet Member for Resources, said: "I welcome the approval of the Council Tax Reduction Scheme for 2023-2024 and it's pleasing that the maximum level of support remains at 100% for eligible claimants, particularly during the ongoing cost-of-living crisis. I would like to remind residents that the council are here to help. If anyone is struggling with their council tax bills, they should contact the council to find out if they are eligible for any support."

Cabinet Members discuss Medium Term Financial Strategy

Bridgend County Borough Council's Cabinet met recently to discuss the authority's proposed Medium Term Financial Strategy (MTFS) for 2023-24 to 2026-27.

Following on from the meeting of Cabinet, the strategy will shortly be undergoing further scrutiny by cross party councillors ahead of it being presented to full council on 1 March 2023.

Outlined in the document is a financial forecast for 2023-2027 and a detailed draft revenue budget for 2023-24, setting out the spending priorities of the council, key investment objectives and budget areas earmarked for necessary savings. This year's draft MTFS has been significantly guided by the proposed objectives in the authority's new Corporate Plan, which will be presented to Council for approval alongside the MTFS 2023-2027 in March.

The Corporate Plan will be fully aligned with the MTFS including explicit links between resources and wellbeing objectives. Even though, by its very nature, the council is a large and complex organisation, offering multiple services to local communities and people, its key objective remains to work as one single organisation, avoiding duplication and double handling of data through sharing of systems and processes. 'One council working together to improve lives' is enshrined in the Council's vision.

Like many organisations, the council has suffered from significant cost pressures and loss of income as a result of the Covid-19 pandemic, along with inflationary pressures as a result of the conflict in Ukraine, plus the impact of the cost of living crisis on both pay and prices, particularly for fuel and energy.

The changing economic climate during the financial year has been unprecedented; with rising inflation around the world, budget planning for the financial year 2023-24 is more uncertain and challenging than usual.

There are fewer opportunities to cut services in a climate that requires more support for our older and more vulnerable members of society with substantial increased demand for many services.

Local authorities get the majority of their revenue funding from Welsh Government through the Revenue Support Grant and a share of Non Domestic Rates. It supplements this through council tax collection, other grants and fees and charges. Council tax currently funds around 27 per cent of the budget, meaning that for every £1 spent on services provided by the council, only around 27 pence is funded from council tax. Based on the proposed net budget of almost £320 million, the strategy will include an initial proposal for council tax to increase to six per cent for 2023-24.

The council's Cabinet Member for Resources, Councillor Hywel Williams said: "The Medium Term Financial Strategy is very much a draft proposal at this stage. The proposal will undergo further scrutiny at a number of committee meetings later this month, ahead of it being presented to full council on 1 March. The scrutiny of the budget forms part of the overall budget planning process, along with the public consultation that is currently underway. The council's Cabinet is committed to keeping council tax levels as low as feasibly possible, recognising the impact of the cost of living crisis on households. However, it is important to recognise that inflation is currently running at a level of over 10 per cent and the council is facing unprecedented pressures in some services, as well as huge cost increases for amenities such as energy usage. We have also taken into consideration in this proposal that the most vulnerable members of our communities are eligible for additional support, such as the Council Tax Reduction Scheme and discounts on their energy bills.

We are still working through some of the additional cost pressures we face and, if at all possible, we will seek to reduce the proposed level of council tax further but the current proposals are consistent with the average increases proposed across Wales currently."

Council approves plans to tackle empty properties

Bridgend County Borough Council's Cabinet has approved plans for the authority to join Welsh Government's National Empty Properties Scheme, whilst proposals to introduce a council tax premium on long term empty properties were given the go ahead at full council.

Both plans are aimed at bringing more empty properties back into use and will help to increase the supply of affordable housing across the county borough. As part of the National Empty Properties Scheme, the council is now required to enter into a Service Level Agreement with Rhondda Cynon Taf Council who have been confirmed as the scheme's lead authority. There is also a commitment to match funding on a case-by-case basis to the level of approximately £124,000.

To qualify for the grant, a property must have been registered as 'empty' with the council for a minimum period of 12 months before the start of any works.

Aside from property owners, registered social landlords, local authorities and community housing groups will also be able to access the funding which will be used to bring these properties back into use as affordable housing.

The terms of the scheme include:

- Only one application per person
- The maximum grant per application will be £25,000
- Energy efficiency improvements will be a requirement as part of the works undertaken on the property
- A minimum 15% applicant contribution will be required
- Any other costs above the grant and contribution must be met by the applicant

Once the works have been completed, the successful applicant must then live in that property as their main and only residence for a minimum of five years.

The scheme will be fully operational from 1st April 2023; however, Welsh Government launched the scheme on 30 January 2023 to allow applications to be made prior to the start of the new financial year.

To further reinforce the council's commitment to bringing more properties back into use, it has also been agreed to introduce a 100% council tax premium on long term empty properties which will come into force on 1 April 2023.

Councils in Wales have the powers to implement council tax premiums on long term empty properties and second homes under the Housing (Wales) Act 2014. Any additional money raised through these charges will be used to support local housing needs.

Cllr Rhys Goode, Cabinet Member for Future Generations and Wellbeing, said: "When so many people are facing the very real threat of homelessness, we have a responsibility to do everything we can to ensure more empty properties are being brought back into use.

"We are desperate for more homes in Bridgend County Borough and we hope these measures provide both a carrot and a stick approach to encourage owners to bring their properties back into use for the benefit of the community."

£21m funding for community projects in Bridgend County Borough

More than £21m is set to support a range of community projects in Bridgend County Borough following a successful application to the Shared Prosperity Fund. The money has been allocated towards specific initiatives and includes schemes that range from the Great Glamorgan Way - a 270km network of 'green corridors' which will connect communities throughout the region - to funding for new tourism events, projects designed to improve adult literacy, a new local enterprise support programme and more. Around £8m of the funding will be used to establish a range of initiatives that will enable people to learn new skills, gain new qualifications and abilities, and ultimately find long term permanent work. More than £3.5m will be used to set up new centres of enterprise across the county borough, while just over £1m will support health, climate and economical projects to help develop stronger and more resilient local communities. A further £2m will be used for community capacity projects such as establishing a new third sector fund and extending grants in support of commercial properties beyond local town centres. Welcoming news that the funding has been approved, Councillor Neelo Farr, Cabinet Member for Regeneration, said: "This is excellent news and the £21m will be used to fund projects that deliver a wide range of positive outcomes for local people across all of the county borough, especially within our valley communities. Designed to replace European structural funds, the Shared Prosperity Fund is intended to support projects which boost productivity, pay, jobs and living standards and to encourage the private sector to grow and create opportunities. It seeks to support projects which instil a sense of community, local pride and belonging, improve public services and empower local leaders and communities.


Opportunities to access the funding, which will be in place until March 2025, will be announced soon."
